TEACHING AND EXAMINING EXPERIENCE

I regularly teach Edinburgh undergraduate medical students who are attached to the vascular unit. This involves discussion and clinical examination at the bedside and formal tutorials.

I also formally lecture to 3rd MB students on 'Veins and Arteries' and 'Acute and Chronic Arterial Disease' as well as formal lectures to 1st MB students on 'Arteries – Anatomy, Function and Clinical Correlation' and 'Veins – Anatomy, Function and Clinical Correlation'

During student examinations, I have, on several occasions examined for the Final MB OSCE exams. I have also been actively engaged in the setting up of the old FRCS examinations in the past. More recently, I have recruited patients for the MRCS OSCE examinations held at the RCSEd, in providing patients with Vascular Disease.

SECONDMENTS

I spent 6 months of my Higher Surgical Training based at Hull Royal Infirmary Vascular Unit. This gave me further exposure in operating on major cases. My time at Hull also allowed me to learn basic Duplex techniques used in the diagnosis of arterial and venous disease. I also spent time in the Radiology department learning angiography and angioplasty techniques and was involved in combined vascular procedures with the Radiologists.

During my time spent in Hull, I gained a large amount of experience in renal access work including fistulae creation, insertion of lines and peritoneal dialysis catheters. This period also allowed me to gain further skills in dealing with 'difficult' major cases and redo vascular surgery. The on call commitment included general surgical emergencies which again, added to good all round experience with the elective and emergency vascular workload.
